

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://goldbowproperties.com>, and Goldbow Properties LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Goldbow Properties LLC include <https://goldbowproperties.com>. Personal Information Collection

In order to better provide you with products and services offered, Goldbow Properties LLC may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may

be required to provide certain personal information to us when you elect to use certain products or services.
